

True Potential Balanced Income Portfolio

Portfolio Objective

The objective of the True Potential Balanced Income Portfolio is to provide investors with a way to achieve their investment goals. This may be total return or a regular income. The Portfolio offers exposure to a select group of investment partners and a range of risk profiles, whilst remaining within the Balanced risk profile. We review the Portfolio monthly and, if necessary, rebalance to the allocation of styles we believe offers the best potential for yield within the Balanced risk profile. The Portfolio aims to produce a higher yield compared to an equally-weighted model of True Potential Wealth Strategy income funds.

Investment Commentary

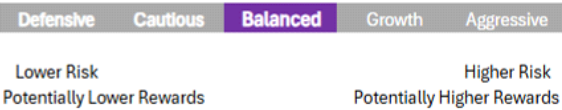
The True Potential Balanced Income Portfolio returned +0.77% in August 2025.

In August, global equities rose again, with MSCI ACWI up 2.5% in USD terms (+14.7% YTD), driven by strong Q2 earnings (75% of US firms beat estimates). However, weaker US jobs data and Fed Chair Powell's Jackson Hole comments signalled a potential policy shift, dampening sentiment. International returns were moderated by the Pound, which strengthened +2.3% against the US Dollar, moderating returns for Sterling investors. Japanese equities were positive after reaching a trade agreement with the US (+4.5%). US equities rose (+2.0%), led by small caps (+7.0%), though some large tech names underwhelmed. Europe and the UK lagged (1.0% and +1.2%) amid inflation surprises and political uncertainty. Global government bonds gained 1.6% as rate cut expectations rose. UK yields climbed on inflation and stagflation concerns. Credit markets held firm; both IG and HY performed well. Gold rose 4.8% as inflation-hedging demand grew.

Schroders Cautious Income delivered the best returns, supported by gold miners, alternatives, and reduced government bond exposure. UBS Income also contributed, while TrinityBridge underperformed. We trimmed TrinityBridge by 1% and increased Schroders. reallocated it to Schroders. TrinityBridge has delivered strong returns in the period of disinflation, and we decided to diversify the manager blend. Schroders, with the strongest long-term track record in the suite, benefits from high-quality manager selection. This move increased UK equity exposure over corporate bonds, improving value with minimal income impact. Managers remain active. TrinityBridge added investment trusts at attractive discounts, while Schroders rotated UK equity income holdings to create a more balanced style exposure.

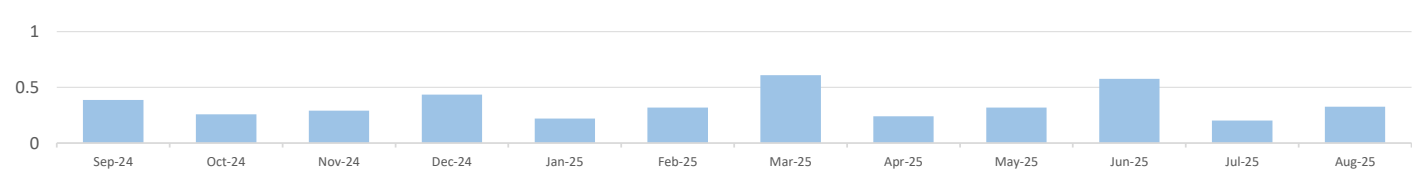
Growth of hypothetical £10,000 invested since inception

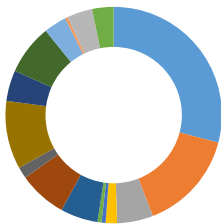
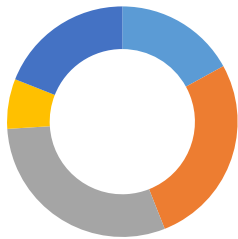

What are the fees associated with investing in this Portfolio?

The OCF of this Portfolio is currently 0.76%. This means that if you invest £1000 in the Portfolio, you can expect to pay £7.57 in fees over the course of a year. The fees you pay are pro-rata. If you hold the Portfolio for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk Type	Description
