

True Potential Defensive Portfolio

Portfolio Objective

The objective of the True Potential Defensive Portfolio is to provide investors with a way to achieve their investment goals. The Portfolio offers full exposure to different manager styles within the Defensive risk profile. We review the Portfolio monthly and, if necessary, rebalance to the allocation of styles that we believe offers the best opportunity for growth within the Defensive risk profile. The Portfolio aims to produce a higher risk-adjusted outcome at a lower average cost, compared to an equally-weighted model of Defensive funds.

Risk and Reward Profile



The Defensive Investor may be very sensitive to short-term losses. A Defensive Investor's potential aversion to short-term losses could compel them to sell their investment and hold a zero risk investment instead if losses occur. Defensive Investors would possibly accept lower long-term return in exchange for smaller and less frequent changes in portfolio value. Analysing the risk-return choices available, a Defensive Investor is usually willing to accept a lower return in order to assure the safety of his or her investment.

Investment Commentary

The True Potential Defensive Portfolio returned +1.95% in February 2026.

Global equities continued their positive start to the year, and investors continued to diversify away from US stocks, as the supreme court ruling on President Trump's tariffs provided further support for ex-US regions. Japan (+10.5%) was the top performer, supported by the snap election result at the beginning of the month. Strong returns from Taiwan and South Korea supported Emerging Market (+5.5%) returns. In contrast, the US (-0.8%) lagged on continuing concerns about the future returns on investment from Tech stocks, with Software companies under pressure. Global bond markets provided positive returns over the month. US and UK government bond yields dropped significantly as a result of subdued labour markets and benign inflation prints across both regions, meaning price returns were positive. In currency markets, the US Dollar appreciated against all major currency pairs as safe-haven demand increased given elevated geopolitical risks.

Portfolio returns were supported by Growth-Aligned, which benefitted from a preference for international equities outside of the US, as well as strong performance from appointed active managers. Within fixed income, the allocation to UK Gilts were also a tailwind to returns. SEI also provided strong returns over the month, benefitting from their allocation to defensive equities as well as to UK bonds within fixed income.

No manager allocation changes were made this month, as we believe current positioning remains optimal. Key changes from managers include UBS reducing corporate bonds and adding to more defensive equities and Emerging Market bonds, Pictet adding to UK and US government bonds and Growth-Aligned adding to UK and Emerging Market equities.



As a result, some of our fund OCFs (Ongoing Charges Figure) have significantly decreased, reflecting only the costs that directly affect the fund's assets.

What are the fees associated with investing in this Portfolio?

The OCF of this Portfolio is currently 0.67%. This means that if you invest £1000 in the Portfolio, you can expect to pay £6.73 in fees over the course of a year. The fees you pay are pro-rata. If you hold the Portfolio for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk Type	Description
