

True Potential Cautious Income Portfolio

Portfolio Objective

The objective of the True Potential Cautious Income Portfolio is to provide investors with a way to achieve their investment goals. This may be total return or a regular income. The Portfolio offers exposure to a select group of investment partners and a range of risk profiles, whilst remaining within the Cautious risk profile. We review the Portfolio monthly and, if necessary, rebalance to the allocation of styles we believe offers the best potential for yield within the Cautious risk profile. The Portfolio aims to produce a higher yield compared to an equally-weighted model of True Potential Wealth Strategy income funds.

The Cautious Investor may be sensitive to short-term losses. Analysing the risk-return choices available, a Cautious Investor is usually willing to accept somewhat lower returns in order to assure greater safety of his or her investment.

Investment Commentary

The True Potential Cautious Income Portfolio returned +2.42% in February 2026.

Global equities continued their positive start to the year, and investors continued to diversify away from US stocks, as the supreme court ruling on President Trump's tariffs provided further support for ex-US regions. Japan (+10.5%) was the top performer, supported by the snap election result at the beginning of the month. Strong returns from Taiwan and South Korea supported Emerging Market (+5.5%) returns. In contrast, the US (-0.8%) lagged on continuing concerns about the future returns on investment from Tech stocks, with Software companies under pressure. Global bond markets provided positive returns over the month. US and UK government bond yields dropped significantly as a result of subdued labour markets and benign inflation prints across both regions, meaning price returns were positive. In currency markets, the US Dollar appreciated against all major currency pairs as safe-haven demand increased given elevated geopolitical risks.

Portfolio returns were supported by Threadneedle, which benefitted from having the largest equity allocation and supported by returns on offer in the UK. The fund demonstrated strong stock selection within healthcare and consumer companies. Goldman Sachs Income Builder also provided strong returns over the month, also demonstrating strong stock selection including within consumer companies but on a global basis.

No manager allocation changes were made this month, as we believe current positioning remains optimal. Key changes from managers include UBS reducing US corporate bonds and adding to US and Emerging Market equities, TrinityBridge adding to select companies in the UK and Europe and Goldman Sachs increasing Technology exposure in the US after a period of underperformance.



What are the fees associated with investing in this Portfolio?

The OCF of this Portfolio is currently 0.81%. This means that if you invest £1000 in the Portfolio, you can expect to pay £8.09 in fees over the course of a year. The fees you pay are pro-rata. If you hold the Portfolio for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk Type	Description
