Fund objective

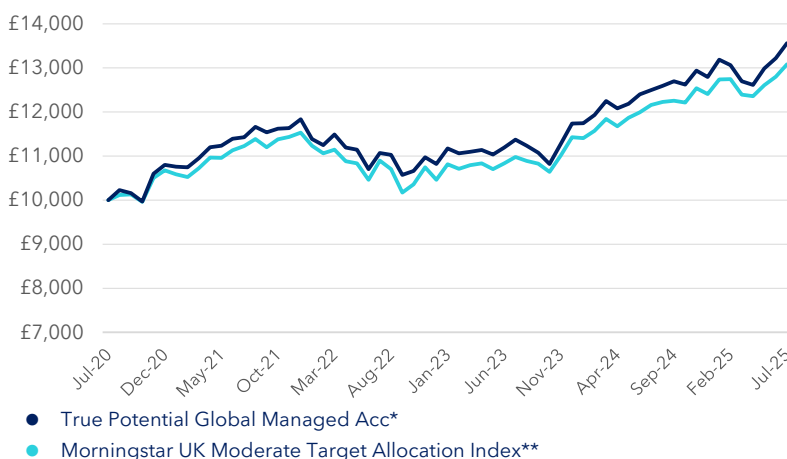
The Fund aims to achieve growth over the medium term (3 years or longer).

July Update

Risk assets extended their rally in July, supported by US tariff deals and strong quarterly earnings. In developed markets, US equities outperformed while European and UK shares delivered solid gains in local-currency terms but lagged global equities. Meanwhile, Emerging Market (EM) equities outpaced their global counterparts, led by China, Taiwan and Korea. In fixed income, corporate bonds delivered modest gains while sovereign bonds underperformed amid higher yields.

The True Potential Global Managed Fund returned 2.58% (net of fees). The Fund's allocation to equities proved advantageous overall, with the exposures to global, UK and EM shares performing well. The Fund's holding in the L&G International Index portfolio notably contributed, as did the allocation to the Franklin FTSE China UCITS ETF and the L&G Global EM Index portfolio. Meanwhile, the underexposure to US equities detracted, while the Fund's allocation to the iShares S&P 500 Equal Weight portfolio lagged the S&P 500 benchmark index, which was another hindrance. In fixed income, the Fund's exposures to EM debt, US high-yield and global corporate credit were supportive as global sovereign bonds underperformed amid higher yields. In alternatives, gold provided the most notable positive contribution while the Fund's allocation to the BlackRock ICS Sterling Liquidity Fund delivered modest gains in absolute terms. Elsewhere, increasing the Fund's exposure to the US dollar helped performance as it strengthened significantly against sterling in July.

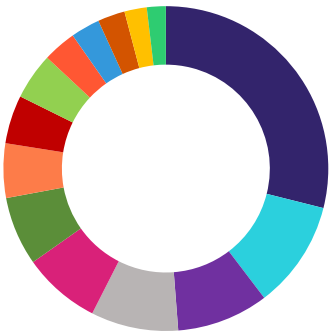
What are the fees associated with investing in this fund?

The OCF of this fund is currently 0.32%. This means that if you invest £1000 in the fund, you can expect to pay £3.20 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
