## Fund objective

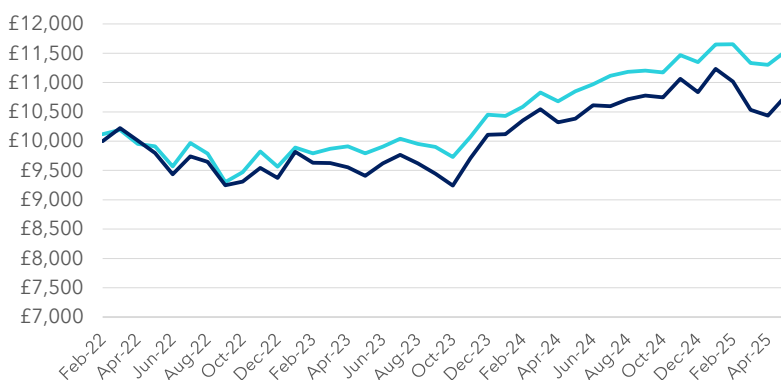
The Fund seeks to deliver growth over a rolling 3 year period net of fees.

## May Update

Risk assets extended their recovery in May, supported by a partial rollback of Trump's tariffs. In developed markets, US equities led the rally while European bank stocks also enjoyed strong gains. Emerging Market (EM) equities also rose but lagged their global counterparts. In fixed income, sovereign bonds underperformed as Treasury yields edged higher but high-yield bonds performed well. Elsewhere, the gold rally came to a halt as investors favoured riskier segments of the market.

The True Potential Pictet Balanced Fund returned 3.16% (net of fees). The Fund's lower exposure to equities was unfavorable in a strong month for the asset class. More positively, the allocation to global thematic equity funds was mostly beneficial. The Fund's exposure to the robotics, digital and premium brands themes provided most notable positive contributions, while high dividend yield underperformed global equities. A modest exposure to European banks and Hong Kong-listed technology shares also helped returns. In fixed income, the Fund's allocation to sovereign bonds detracted overall, with long-dated UK Gilts faring the worst. US inflation-linked Treasury bonds performed better yet still declined in absolute terms. Conversely, the exposure to high-yield bonds and EM local-currency debt aided performance. In alternatives, the Fund's allocation to gold detracted but the Fund's exposure to commodities overall was advantageous. In addition, the Fund benefited from partially hedging the US dollar exposure back to sterling.

## What are the fees associated with investing in this fund?

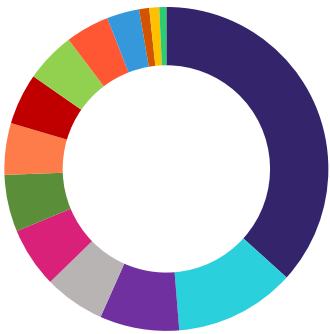
The OCF of this fund is currently 0.84%. This means that if you invest £1000 in the fund, you can expect to pay £8.40 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
