Fund objective

The Fund seeks to deliver growth over a rolling 3 year period net of fees.



June Update

Risk assets delivered further gains in June, supported by easing trade tensions. In developed markets, US equities led the rally while UK mid- and small-cap stocks outperformed. European shares initially rose but ended lower, amid rising tensions in the Middle East. Emerging Market (EM) equities outpaced their global counterparts. In fixed income, riskier high-yield bonds outperformed. Elsewhere, gold price edged lower.

The True Potential Pictet Defensive Fund returned 1.40% (net of fees). The Fund's lower exposure to equities was unfavorable in a strong month for the asset class. More positively, the allocation to global thematic equity funds was mostly beneficial. The Fund's exposure to the robotics and digital themes provided the most notable positive contributions and outpaced broader global equities. Conversely, the premium brands theme underperformed. Elsewhere, a modest exposure to EMs through Hong Kong-listed technology shares was supportive. On the other hand, the Fund's exposure to European equities was a drag on returns. In fixed income, the Fund's allocation to sovereign bonds produced mixed results as inflation-linked UK Gilts and European Union bonds declined while US inflation-linked Treasury bonds performed well. Meanwhile, the allocation to high-yield bonds and EM local-currency debt (EMD) was supportive, with EMD producing the best absolute returns within the segment. In alternatives, the Fund's exposure to commodities overall was advantageous but gold was relatively flat. In addition, the Fund benefited from partially hedging the US dollar exposure back to sterling.

Risk type	Description
