Fund objective


The Fund seeks to deliver long term (five years plus) growth and income from exposure, directly or indirectly, to a diversified portfolio which will mainly (at least 50%) be achieved through other investment funds.

June Update

Risk assets delivered further gains in June, supported by easing trade tensions. In developed markets, US equities led the rally while UK mid- and small-cap stocks outperformed. European shares initially rose but ended lower, amid rising tensions in the Middle East. Emerging Market (EM) equities outpaced their global counterparts. In fixed income, riskier high-yield bonds outperformed. Elsewhere, gold price edged lower.

The True Potential Schroders Balanced Fund returned 1.39% (net of fees). The Fund's lower allocation to equities overall was a hindrance in a strong month for the asset class. The Fund's lack of exposure to US equities was the most notable detractor as US shares significantly outpaced their global counterparts for the second consecutive month. A sizeable exposure to Japanese equities was also unhelpful. More positively, the Fund's allocation to the Heptagon Kopernik Global Equity Fund produced the best returns overall. The Fund's exposure to EM also was a notable contributor, with the Artemis Global Emerging Markets Fund and the Man GLG Asia (Ex-Japan) Fund performing well. In alternatives, the allocation to Iguana Long/Short Equity Fund produced the best absolute returns within the segment, followed by the QSM Global Equity Long/Short Fund. In fixed income, all of the Fund's allocations delivered positive returns, but the Fund did not fully participate in the sovereign bond rally due to its lack of exposure to long-dated bonds. Elsewhere, exposure to the iShares Physical Gold Fund provided a modest negative contribution.

Risk type	Description
