

## True Potential Schroders Balanced

### Fund objective


The Fund seeks to deliver long term (five years plus) growth and income from exposure, directly or indirectly, to a diversified portfolio which will mainly (at least 50%) be achieved through other investment funds.

### November Update

Global equities were volatile in October yet ended flat as sentiment recovered towards the end of the month. In developed markets, European and UK shares outperformed, while Japanese shares underperformed. Emerging Market (EM) shares proved a laggard, dragged down by weakness in China. In fixed income, US Treasuries outperformed amid lower yields. Elsewhere, gold delivered solid gains, supported by a softer US dollar.

The True Potential Schroders Balanced Fund returned 1.01% (net of fees), with the Fund's lower allocation to equities proving advantageous in a volatile month for the asset class. The active manager selection within global, Japanese and European equities was also beneficial. The exposure to the Heptagon Kopernik Global Equity Fund was particularly advantageous as it outpaced global equities by some distance. Conversely, the Fund's allocation to EM and Asian equities weighed on performance as the Man GLG Asia (Ex-Japan) Fund and the Artemis Global Emerging Markets Fund produced negative returns. The Fund's preference for alternatives geared towards long value/short growth was also supportive as the value style outperformed over the month. A sizeable allocation to the Montlake Invenomic US Equity Long/Short fund performed particularly well. Elsewhere, smaller allocations to fixed income and physical gold provided a positive contribution.

## What are the fees associated with investing in this fund?

The OCF of this fund is currently 1.23%. This means that if you invest £1000 in the fund, you can expect to pay £12.30 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).
