Fund objective


The investment objective of the Fund aims to deliver a total return in excess of inflation (UK Consumer Price Index) while aiming to provide an income of 3-5% per year on average, over rolling 5-year periods (net of fees).

February Update

Global equities delivered further gains in February as value style shares significantly outperformed their growth style peers. Emerging Market (EM) equities markedly outpaced their developed market counterparts despite weakness in China. In developed markets, Japanese shares led the gains, while US equities proved a laggard. In fixed income, long-dated UK Gilts outperformed amid lower yields.

The True Potential Schroders Cautious Income Fund returned 2.97% (net of fees), with the Fund's exposure to gold miners and energy shares driving returns within the equity segment. The allocation to the Schroder ISF Global Gold USD Fund was the most notable contributor over the period, followed by the exposure to the SISF Global Energy I Fund. The Fund's sizeable allocation to the Man GLG Income Fund and the Jupiter UK Multi Cap Income Fund also performed well. The allocation to alternatives was beneficial and outperformed sovereign bonds, supported by solid gains from gold and large exposures to the QSM Global Equity Long/Short Fund and the Montlake Invenomic US Equity Long/Short Fund. Elsewhere, the allocation to fixed income produced gains in absolute terms, driven by solid returns from the iShares USD Treasury Bond 7-10-year ETF (hedged to sterling).

What is the benchmark for this fund?

The benchmark for this fund is Consumer Price Index (UK CPI). The benchmark may be used as a guide to compare and assess the performance of the Fund. 
What are the fees associated with investing in this fund?

The OCF of this fund is currently 1.08%. This means that if you invest £1000 in the fund, you can expect to pay £10.80 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
