Fund objective

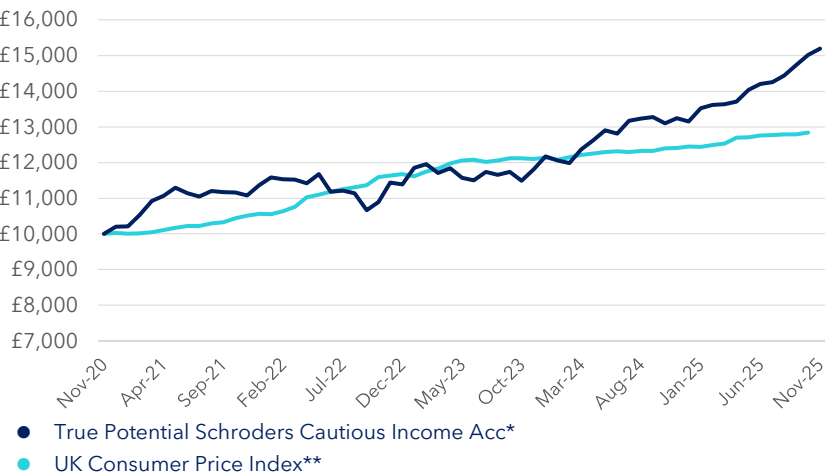
The investment objective of the Fund aims to deliver a total return in excess of inflation (UK Consumer Price Index) while aiming to provide an income of 3-5% per year on average, over rolling 5-year periods (net of fees).

November Update

Global equities were volatile in October yet ended flat as sentiment recovered towards the end of the month. In developed markets, European and UK shares outperformed, while Japanese shares underperformed. Emerging Market (EM) shares proved a laggard, dragged down by weakness in China. In fixed income, US Treasuries outperformed amid lower yields. Elsewhere, gold delivered solid gains, supported by a softer US dollar.

The True Potential Schrodgers Cautious Income Fund returned 1.18% (net of fees), with the Fund’s lower allocation to equities proving advantageous in a volatile month for the asset class. A sizeable allocation to the Jupiter UK Multi Cap Income Fund produced the best returns within the equity segment, followed by a smaller exposure to the Schroder Income Maximiser fund. In fixed income, all the allocations delivered gains, with US Treasuries outpacing UK Gilts as yields edged lower. The Fund’s exposure to alternatives geared towards long value/short growth was also supportive as the value style outperformed over the month. A sizeable allocation to the Montlake Invenomic US Equity Long/Short fund performed particularly well. Elsewhere, a modest allocation to physical gold provided a positive contribution.

What is the benchmark for this fund?

The benchmark for this fund is UK Consumer Price Index (UK CPI). The benchmark may be used as a guide to compare and assess the performance of the Fund. This fund uses the UK CPI which measures the rate of inflation in the UK, reflecting changes in the prices of a broad range of goods and services. By comparing the fund’s performance against the UK CPI, the fund aims to ensure its returns outpace inflation, thereby maintaining the real value of investors’ capital over time. Our aim is to help you monitor how your investment is performing. The Fund uses the benchmark as a target. The Fund is not constrained by it.

Key fund information

Who is this fund suitable for?

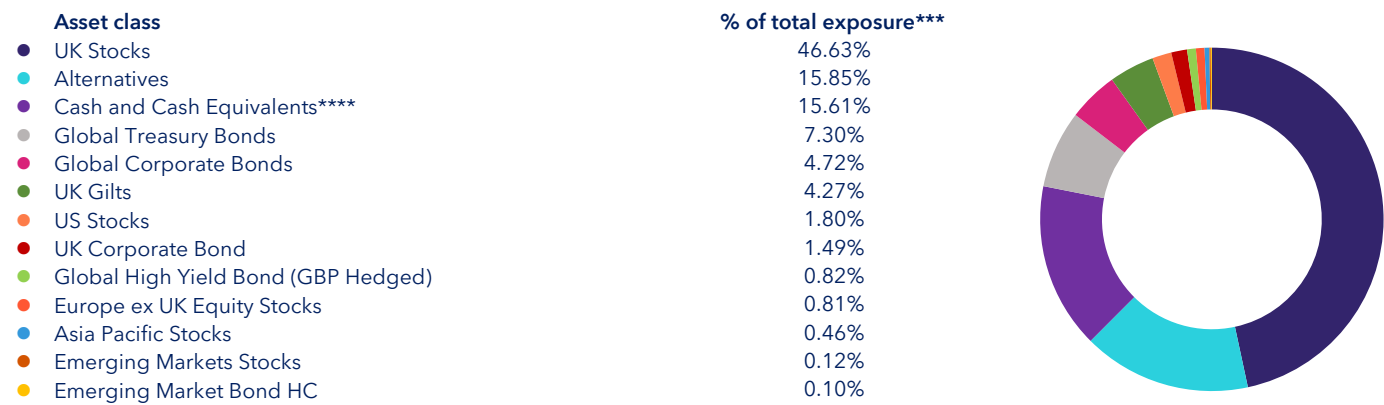

What are the fees associated with investing in this fund?

The OCF of this fund is currently 1.07%. This means that if you invest £1000 in the fund, you can expect to pay £10.70 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
