Fund objective

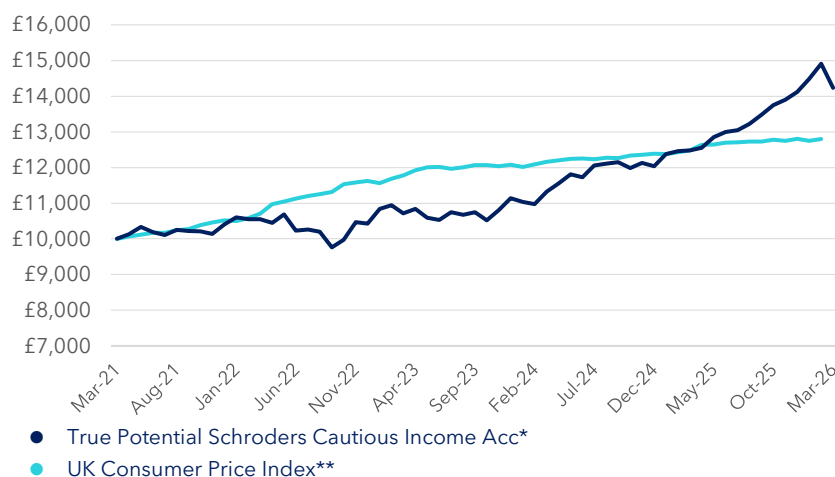
The investment objective of the Fund aims to deliver a total return in excess of inflation (UK Consumer Price Index) while aiming to provide an income of 3-5% per year on average, over rolling 5-year periods (net of fees).

March Update

Global equities fell sharply in March as war in the Middle East sparked a sell-off across all risk assets. Emerging Market (EM) equities markedly underperformed their developed market counterparts. In developed markets, Japanese shares proved a laggard, while US equities fared better yet also notably declined. In fixed income, UK Gilts underperformed, with longer-dated bonds particularly weak amid higher yields. Elsewhere, oil rallied while gold tumbled amid a stronger US dollar.

The True Potential Schroders Cautious Income Fund returned -4.56% (net of fees), with the Fund's exposure to gold miners via the Schroder ISF Global Gold USD Fund proving detrimental. More positively, the allocation to energy shares via the SISF Global Energy I Fund produced the best gains overall as oil prices rallied. The alternatives segment delivered mixed returns yet outperformed the sovereign bonds. The Fund's sizeable exposure to the Montlake Invenomic US Equity Long/Short Fund delivered solid gains. Elsewhere, the allocation to fixed income produced losses in absolute terms with UK Gilts weighing on returns.

What is the benchmark for this fund?

The benchmark for this fund is Consumer Price Index (UK CPI). The benchmark may be used as a guide to compare and assess the performance of the Fund. This fund uses the UK CPI which measures the rate of inflation in the UK, reflecting changes in the prices of a broad range of goods and services. By comparing the fund's performance against the UK CPI, the fund aims to ensure its returns outpace inflation, thereby maintaining the real value of investors' capital over time. 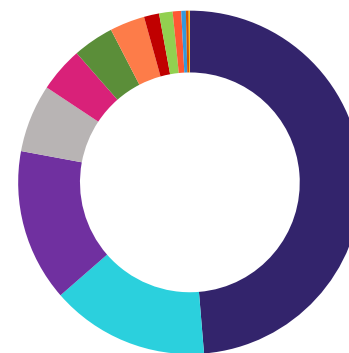
What are the fees associated with investing in this fund?

The OCF of this fund is currently 1.08%. This means that if you invest £1000 in the fund, you can expect to pay £10.80 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
