

True Potential Schroders Cautious Income

Fund objective

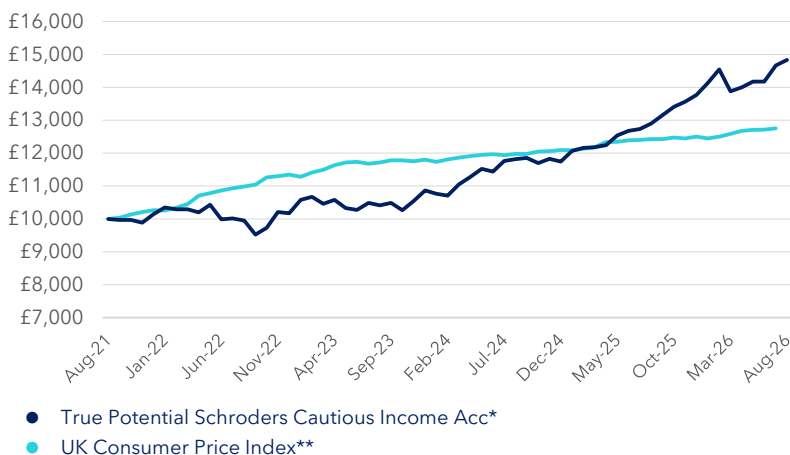
The investment objective of the Fund aims to deliver a total return in excess of inflation (UK Consumer Price Index) while aiming to provide an income of 3-5% per year on average, over rolling 5-year periods (net of fees).

August Update

Global equities rose in August, supported by solid corporate earnings and gains in artificial intelligence-linked names. Emerging Market (EM) equities advanced and outpaced their developed market counterparts in US dollar terms, led by strong performance from Taiwan. In developed markets, Japanese and US shares outperformed, while UK equities proved a laggard. In fixed income, EM debt and high-yield (HY) bonds delivered the best returns. Elsewhere, gold prices rallied amid a softer dollar.

The True Potential Schroders Cautious Income Fund returned 1.14% (net of fees), with the Fund's allocation to gold miners via the Schroder ISF Global Gold USD Fund driving performance over the month. The Fund's exposure to energy via the SISF Global Energy I Fund was another contributor in August. Less positively, a sizeable allocation to UK equities proved a hindrance, with the Royal London UK Equity Income Fund delivering negative returns, along with the TM Redwheel UK Equity Income Fund. Conversely, the Man GLG Income Fund did well and outpaced broader UK equities. In alternatives, the Fund's allocation to gold provided the most notable positive contribution, followed by the GLG UK Absolute Value Fund. Conversely, the Iguana Long/Short Equity Fund and Montlake Invenomic US Equity Long/Short Fund weighed on returns. The Fund's allocation to fixed income produced modest gains overall yet underperformed equities and alternatives.

What is the benchmark for this fund?

The benchmark for this fund is Consumer Price Index (UK CPI). The benchmark may be used as a guide to compare and assess the performance of the Fund. This fund uses the UK CPI which measures the rate of inflation in the UK, reflecting changes in the prices of a broad range of goods and services. By comparing the fund's performance against the UK CPI, the fund aims to ensure its returns outpace inflation, thereby maintaining the real value of investors' capital over time. Our aim is to help you monitor how your investment is performing. The Fund uses the benchmark as a target. The Fund is not constrained by it.

Who is this fund suitable for?

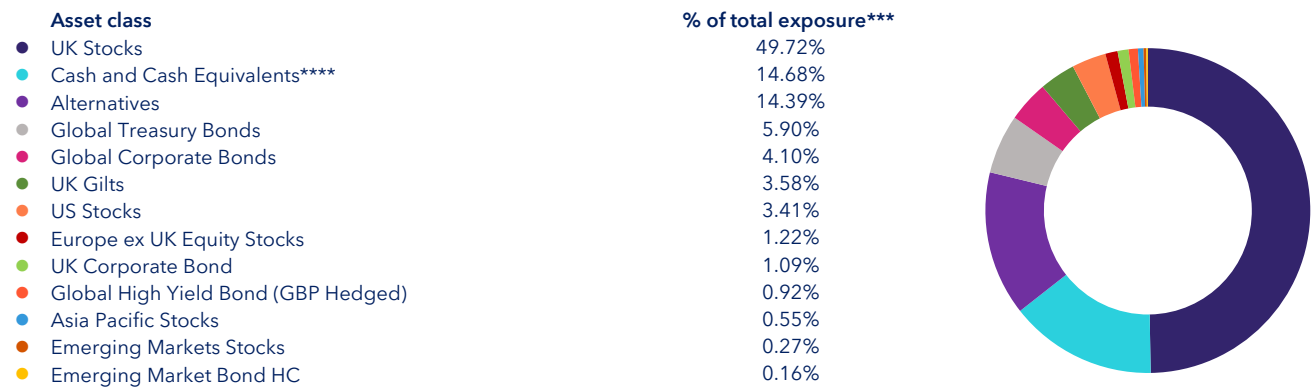

What are the fees associated with investing in this fund?

The OCF of this fund is currently 1.01%. This means that if you invest £1000 in the fund, you can expect to pay £10.10 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
