Fund objective



The Fund aims to provide growth and income by investing directly and indirectly in a selected range of investments in the UK and around the world, mainly in other investment funds which have a global equity and fixed income focus.

July Update

Risk assets extended their rally in July, supported by US tariff deals and strong quarterly earnings. In developed markets, US equities outperformed while European and UK shares delivered solid gains in local-currency terms but lagged global equities. Meanwhile, Emerging Market (EM) equities outpaced their global counterparts, led by China, Taiwan and Korea. In fixed income, corporate bonds delivered modest gains while sovereign bonds underperformed amid higher yields.

The True Potential SEI Cautious Fund returned 1.45% (net of fees). Most of the allocations to index funds that track global equity factors delivered solid gains, with the 'dynamic factor' and 'dynamic asset' portfolios providing the most notable contributions. The 'momentum' factor also performed well, as did the allocation to the SEI Emerging Markets Equity Fund. The 'small cap', 'quality' and 'value' factors also delivered gains but lagged global equities. Conversely, the 'managed volatility' factor was the biggest laggard as investors favoured riskier segments of the market. The Fund's allocation to fixed income assets produced flat returns overall as gains from the SEI Emerging Markets Debt Fund and SEI High Yield Fixed Income Fund were offset by negative contributions from UK Gilts. Elsewhere, the Fund's exposure to the SEI Liquid Alternatives Fund delivered negative returns and lagged sovereign bonds. Meanwhile, US dollar strength against sterling was supportive.
