Fund objective

The Fund aims to achieve income in excess of 3% per year, with growth, over rolling 3-year periods (net of fees).

July Update

Risk assets extended their rally in July, supported by US tariff deals and strong quarterly earnings. In developed markets, US equities outperformed while European and UK shares delivered solid gains in local-currency terms but lagged global equities. Meanwhile, Emerging Market (EM) equities outpaced their global counterparts, led by China, Taiwan and Korea. In fixed income, corporate bonds delivered modest gains while sovereign bonds underperformed amid higher yields.

The True Potential TrinityBridge Cautious Income Fund returned 1.32% (net of fees). The Fund's lower allocation to equites hurt performance in a strong month for the asset class but the preference for UK shares proved supportive. At the stock level, key contributors included Diploma, financial company Pollen Street Group and tobacco firms Imperial Brands and British American Tobacco. Conversely, the most notable detractors included tobacco company Philip Morris and global alternative asset manager ICG Longbow. In fixed income, the Fund's allocation to UK investment grade (IG) bonds was beneficial overall as UK IG bonds outperformed their global counterparts. Conversely, the Fund's modest allocation to long-dated Gilts detracted as UK inflation edged higher. In alternatives, the sizeable allocations to investment companies GCP Infrastructure Investments and HICL Infrastructure delivered solid gains, as did a modest allocation to gold via the Invesco Physical Gold ETC portfolio. Meanwhile, sterling weakness detracted as the Fund hedges half of its overseas currency exposure back to sterling.

Risk type	Description
