Fund objective

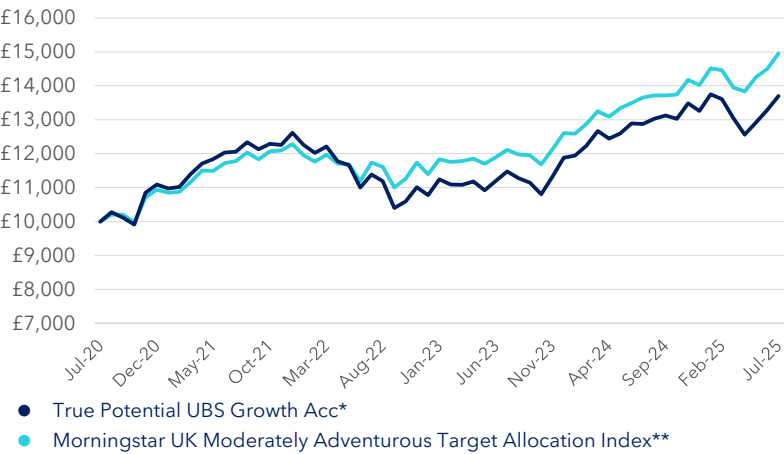
The Fund aims to achieve growth over the long term (5 years or longer) through active management of a diversified investment portfolio whilst seeking to control the overall level of portfolio risk.

July Update

Risk assets extended their rally in July, supported by US tariff deals and strong quarterly earnings. In developed markets, US equities outperformed while European and UK shares delivered solid gains in local-currency terms but lagged global equities. Meanwhile, Emerging Market (EM) equities outpaced their global counterparts, led by China, Taiwan and Korea. In fixed income, corporate bonds delivered modest gains while sovereign bonds underperformed amid higher yields.

The True Potential UBS Growth Fund returned 3.11% (net of fees), with the allocation to EM equities and US shares proving particularly beneficial. Most of the allocations to index funds that track global equity factors also did well, with the UBS FTSE RAFI Developed 1000 Index Fund delivering solid returns. Conversely, the 'momentum' and 'quality' factors underperformed, posting declines in absolute terms. While European equities underperformed their global counterparts, the Fund's allocation to European banks delivered the strongest gains overall, fuelled by solid quarterly results and easing trade tensions. Chinese tech shares also rose amid AI optimism and macro improvement. In fixed income, returns were mixed. While the Fund's allocations to long-dated global sovereign bonds detracted as yields rose, the exposures to global corporate bonds were beneficial, with US investment-grade corporate bonds delivering the best gains within the segment. In alternatives, modest gains from the allocation to gold and silver were offset by a negative contribution from the long/short equity hedge. US dollar strength also hurt performance.

What are the fees associated with investing in this fund?

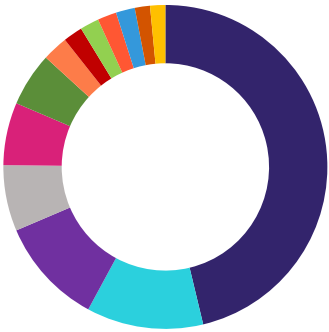
The OCF of this fund is currently 0.63%. This means that if you invest £1000 in the fund, you can expect to pay £6.30 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
