

# True Potential Growth + Portfolio

## Portfolio Objective

The objective of the True Potential Growth + Portfolio is to provide investors with a way to achieve their investment goals. The Portfolio offers exposure to a select group of investment partners and a range of risk profiles (Defensive to Aggressive), whilst remaining within the Capital Growth risk profile. We review the Portfolio monthly and, if necessary, rebalance to the allocation of styles that we believe offers the best opportunity for growth within the Capital Growth risk profile. The Portfolio aims to produce a higher risk-adjusted outcome at a lower average cost, compared to an equally-weighted model of Capital Growth funds.

## Risk Profile: Growth

The Growth Investor may be willing to accept high risk and chance of loss in order to achieve higher returns on his or her investment. Significant losses over an extended period may prompt the Growth Investor to shift to a less risky investment.

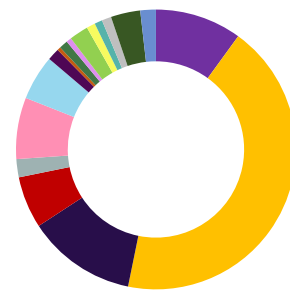
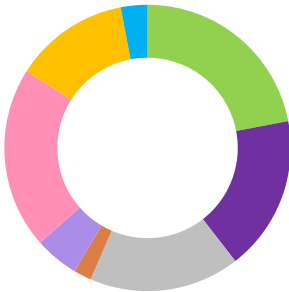

## Investment Commentary

The True Potential Growth + Portfolio returned +4.26% in December 2023, net of Portfolio OCF.

We experienced the second consecutive month of strong asset market returns to close out the calendar year. The key drivers of returns were further signs of falling inflation across developed markets, which gave investors greater optimism Central Banks have reached peak interest rates and have scope to reduce rates through 2024. The magnitude of cuts expected in 2024 increased over December. Whilst Central Bankers aimed to manage these market expectations, recognising inflation across the UK, Europe and US is running ahead of target (2.0%), a more dovish tone was stuck by the US Federal Reserve.

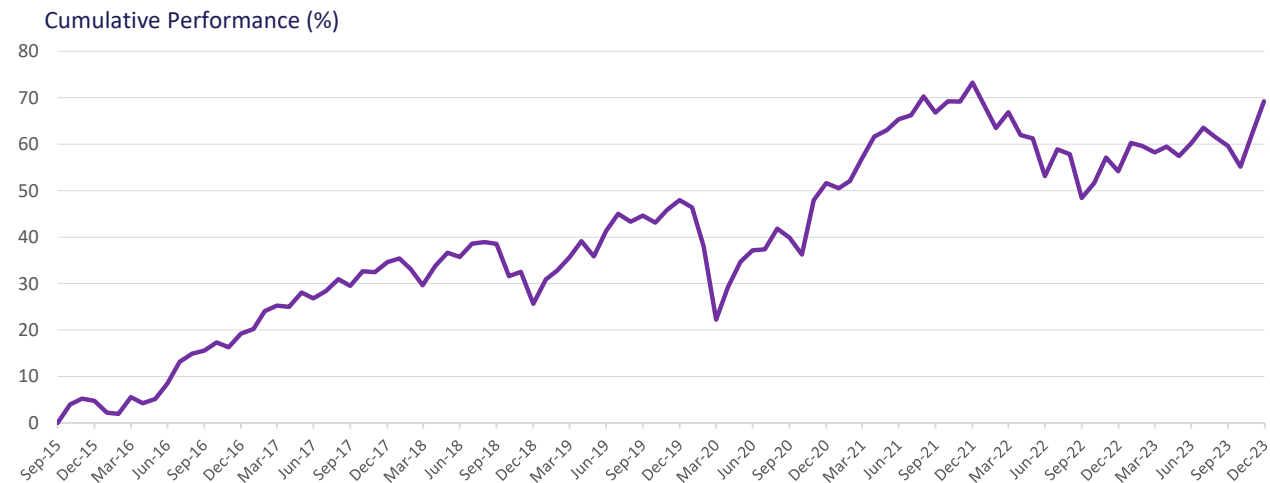
Within the portfolio, stronger performing funds included True Potential UBS Aggressive, benefitting from a larger allocation to equities, including the mix of factors within that allocation helping capture the breadth of market returns. From a fixed income perspective, the UBS fund also benefitted from its allocation to longer dated US government bonds.

Over the period, no changes were made to the Portfolio manager allocations after agreement that the allocations are optimally positioned in line with our longer-term market outlook. However changes have been made at the underlying fund level. Examples include additions to European equities, where lower valuations are seen as attractive, as well as additions to UK Gilts and lower quality corporate bonds globally, to access the high yields on offer where managers have moved less cautious on the economic environment.
