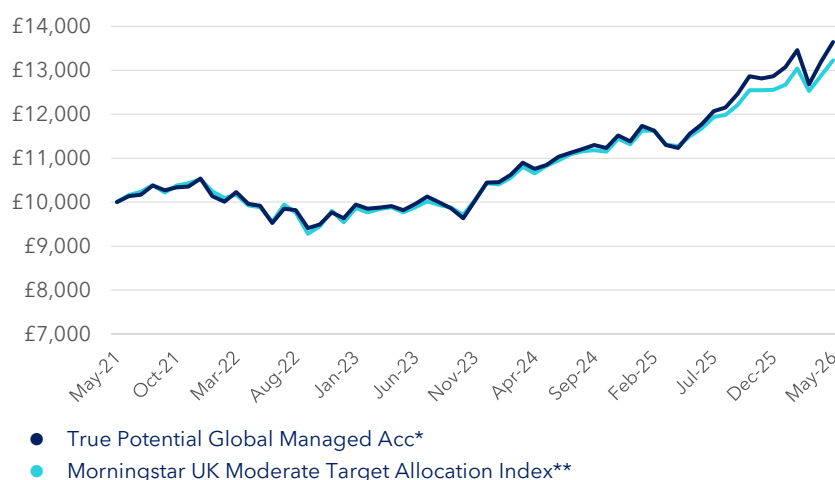

May Update

Global equities rose again in May amid hopes of a de-escalation in the Middle East and rally in artificial-intelligence (AI) names. Emerging Market (EM) equities led the gains and outpaced their developed market counterparts, driven by South Korea and Taiwan. In developed markets, US technology shares outperformed, while UK equities proved a laggard. In fixed income, UK Gilts did well, while US Treasuries underperformed. Elsewhere, gold ended slightly down as the US dollar and yields edged higher.

The True Potential Global Managed Fund returned 3.39% (net of fees). The Fund's preference for EM and Japanese shares drove performance over the month. Conversely, the underexposure to US equities was unhelpful but the negative impact was partially offset by the allocation to US large-cap names via the L&G US Index Fund. In fixed income, the Fund's preference for UK Gilts over US Treasuries was beneficial as Gilts notably outperformed. The preference for conventional sovereign bonds over inflation-linked bonds was also supportive. Elsewhere within the segment, the allocation to EM debt via the L&G EM Government Bond LC Index Fund was also advantageous, as was the allocation to high-yield bonds. In alternatives, gold detracted over the period, while a sizeable exposure to the BlackRock ICS Sterling Liquidity Fund produced modest gains in absolute terms.

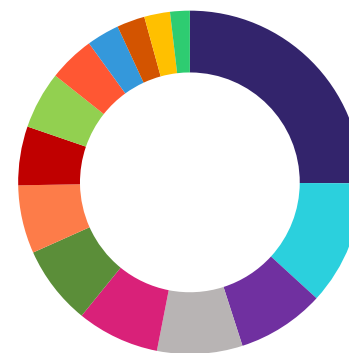
What are the fees associated with investing in this fund?

The OCF of this fund is currently 0.32%. This means that if you invest £1000 in the fund, you can expect to pay £3.20 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
