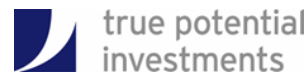


True Potential Cautious Portfolio

31 July 2025



Portfolio Objective

The objective of the True Potential Cautious Portfolio is to provide investors with a way to achieve their investment goals. The Portfolio offers full exposure to different manager styles within the Cautious risk profile. We review the Portfolio monthly and, if necessary, rebalance to the allocation of styles that we believe offers the best opportunity for growth within the Cautious risk profile. The Portfolio aims to produce a higher risk-adjusted outcome at a lower average cost, compared to an equally-weighted model of Cautious funds.

The Cautious Investor may be sensitive to short-term losses. A Cautious Investor's potential aversion to losses could compel them to shift into a more stable investment if significant short-term losses occur. Analysing the risk-return choices available, a Cautious Investor is usually willing to accept somewhat lower returns in order to assure greater safety of his or her investment.

Investment Commentary

The True Potential Cautious Portfolio returned +1.57% in July 2025.

In July, the US reached trade deals with Japan, Europe, and South Korea, easing tariff concerns. Trump's "One Big Beautiful Bill" extended tax cuts and increased spending. Global equities rose sharply, led by the UK and US, hitting new highs. AI optimism and strong earnings, including Nvidia's approval to sell chips to China, boosted US tech stocks.

In fixed income, sovereign bonds declined as UK and US yields rose. US Treasury yields increased on strong data and inflation, while Gilt yields climbed amid inflation and fiscal concerns. High-yield bonds delivered gains, with higher yields and tighter spreads offsetting rising benchmark rates. In currency markets, the US dollar rebounded strongly following weakness year to date, gaining against most currency pairs as trade deals were agreed. With this, the Pound weakened by 3.8% against the dollar, supportive for Sterling-based investors holding dollar assets on an unhedged basis.

The strongest performing fund over the month was True Potential Growth-Aligned Cautious, which benefited from its larger allocation to equities, as well as the allocation to corporate bonds, particularly High Yield. The Schroders Cautious fund, whilst providing a positive return, lagged the other funds in the portfolio due to its lower equity allocation, and within that, a low exposure to the US. The large Alternatives allocation was also a headwind to returns, with some strategies challenged over the month.

No manager allocation changes were made this month; we believe our positioning remains optimal. Within Portfolios, managers continued to build their equity exposure over the month, funded from sovereign bonds and cash, reflecting their positivity on the economic outlook.

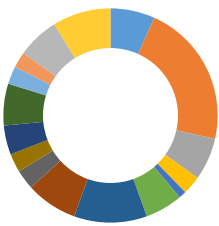
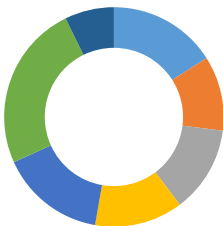

In September 2024, the FCA updated its Packaged Retail Insurance and Investment Products (PRIIPS) guidance on how we disclose costs for closed-ended funds like investment trusts. This change is designed to give you a clearer picture of the actual costs that impact your investments. As a result, some of our fund OCFs (Ongoing Charges Figure) have significantly decreased, reflecting only the costs that directly affect the fund's assets.

What are the fees associated with investing in this Portfolio?

The OCF of this Portfolio is currently 0.78%. This means that if you invest £1000 in the Portfolio, you can expect to pay £7.76 in fees over the course of a year. The fees you pay are pro-rata. If you hold the Portfolio for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk Type	Description
