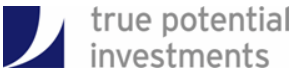


True Potential Growth + Portfolio

Portfolio Objective

The objective of the True Potential Growth + Portfolio is to provide investors with a way to achieve their investment goals. The Portfolio offers exposure to a select group of investment partners and a range of risk profiles (Defensive to Aggressive), whilst remaining within the Capital Growth risk profile. We review the Portfolio monthly and, if necessary, rebalance to the allocation of styles that we believe offers the best opportunity for growth within the Capital Growth risk profile. The Portfolio aims to produce a higher risk-adjusted outcome at a lower average cost, compared to an equally-weighted model of Capital Growth funds.

Investment Commentary

The True Potential Growth+ Portfolio returned +2.75% in September 2025.

Global equities rose in September (MSCI ACWI +3.7%, local) as the Federal Reserve signalled lower interest rates ahead. AI-related stocks led gains despite high valuations. US equities hit record highs (S&P 500 +3.6%) as softer labour data lifted rate-cut expectations. Market breadth stayed narrow (Equal Weight +1.1%), with AI themes leading (NASDAQ +5.7%). Emerging markets outperformed (MSCI EM +7.2%) on tech strength and Chinese fiscal optimism, while the UK (+1.8%) and Europe (+1.5%) lagged amid limited tech exposure and potential UK bank tax hikes. US bond yields fell on weak data before rebounding on stronger growth; gilt yields stayed elevated. Global Investment Grade credit (+1.1%, GBP hedged) outperformed High Yield (+0.7%), and sterling weakened (-0.4%) versus the dollar.

True Potential UBS Aggressive led performance, supported by higher equity exposure, momentum and quality factors, plus gold, silver, and EM debt holdings. Schroders Balanced followed, aided by gold miners and Japanese and EM equities. SEI Aggressive lagged due to its value tilt and smaller-company exposure.

No manager changes were made, as current positioning remains appropriate. Managers stay constructive, adding to gold and Japanese equities (UBS, Growth-Aligned). TrinityBridge increased cyclical and gold exposure; Growth-Aligned also added Japanese equities and longer-dated UK gilts. Schroders, with the largest gold-mining allocation, has begun trimming exposure.

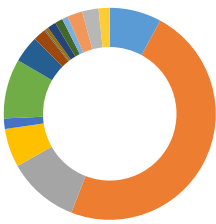
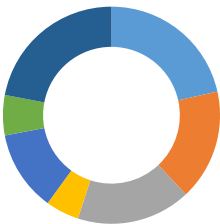

In September 2024, the FCA updated its Packaged Retail Insurance and Investment Products (PRIIPS) guidance on how we disclose costs for closed-ended funds like investment trusts. As a result, some of our fund OCFs (Ongoing Charges Figure) have significantly decreased, reflecting only the costs that directly affect the fund's assets.

What are the fees associated with investing in this Portfolio?

The OCF of this Portfolio is currently 0.73%. This means that if you invest £1000 in the Portfolio, you can expect to pay £7.33 in fees over the course of a year. The fees you pay are pro-rata. If you hold the Portfolio for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk Type	Description
