# **True Potential Cautious Income Portfolio**

31 October 2025

## Portfolio Objective

The objective of the True Potential Cautious Income Portfolio is to provide investors with a way to achieve their investment goals. This may be total return or a regular income. The Portfolio offers exposure to a select group of investment partners and a range of risk profiles, whilst remaining within the Cautious risk profile. We review the Portfolio monthly and, if necessary, rebalance to the allocation of styles we believe offers the best potential for yield within the Cautious risk profile. The Portfolio aims to produce a higher yield compared to an equally-weighted model of True Potential Wealth Strategy income funds.

The Cautious Investor may be sensitive to short-term losses. A Cautious Investor's potential aversion to losses could compel them to shift into a more stable investment if significant short-term losses occur. Analysing the risk-return choices available, a Cautious Investor is usually willing to accept somewhat lower returns in order to assure greater safety of his or her investment.

#### **Investment Commentary**

The True Potential Cautious Income Portfolio returned +1.31% in October 2025.

October was positive for global multi-asset portfolios, with most asset classes gaining and UK investors benefiting from a weaker pound. Markets were lifted by easing US-China trade tensions, solid corporate earnings, and the Federal Reserve lowering interest rates by 0.25% to 3.75%. Equities rose globally, led by Emerging Markets, the US, and Japan. Smaller/medium-sized listed companies lagged in the rally which was a headwind to certain income managers. UK gilts performed strongly as yields fell. Gold was volatile but ended higher, contributing positively to Portfolios.

Portfolio returns were supported by UBS Income, which benefitted from a higher exposure to global equities, particularly Japan and Emerging Markets. True Potential Threadneedle Monthly Income was the top performer, driven by its higher exposure to UK equities. The weakest performer was TrinityBridge Cautious Income, hindered by its a lower equity exposure.

Manager allocations were unchanged in October, with positions deemed appropriate. The team rebalanced to target weights. Key manager actions included Schroders trimming physical gold and gold miners, adding a US Equity long short fund and rotating into a new tactical bond fund.

The OCF of this Portfolio is currently 0.79%. This means that if you invest £1000 in the Portfolio, you can expect to pay £7.93 in fees over the course of a year. The fees you pay are pro-rata. If you hold the Portfolio for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk Type	Description
