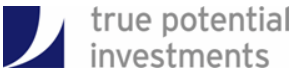


True Potential Growth + Portfolio

Portfolio Objective

The objective of the True Potential Growth + Portfolio is to provide investors with a way to achieve their investment goals. The Portfolio offers exposure to a select group of investment partners and a range of risk profiles (Defensive to Aggressive), whilst remaining within the Capital Growth risk profile. We review the Portfolio monthly and, if necessary, rebalance to the allocation of styles that we believe offers the best opportunity for growth within the Capital Growth risk profile. The Portfolio aims to produce a higher risk-adjusted outcome at a lower average cost, compared to an equally-weighted model of Capital Growth funds.

Investment Commentary

The True Potential Growth + Portfolio returned +2.61% in January 2026.

Global equities made a strong start to the year (MSCI ACWI +3.0%, local currency terms) with Emerging Markets (+8.9%) the standout region, led by Taiwan and South Korea. These regions benefitted from ongoing demand in AI-related technology and strong earnings growth. A snap election in Japan sparked volatility, particularly in bond markets, however Japanese equities (+4.6%) still delivered a strong return on hopes that the ruling coalition will gain control of the lower house. Despite reaching highs during the month, the US was the worst performing equity region (S&P500 +1.4%) as geopolitical risks and concerns around central-bank independence weighed on sentiment. Notable performance outside of equities was in precious metals, as geopolitical tensions sparked a need for diversification. Gold delivered exceptional returns (+13.3%) in January but price moves have since been volatile and negative as uncertainty has eased. In bond markets, both US and UK government bond yields rose over January, negative for price returns. US yields rose as an improving balance of risks pushed out expectations for interest rate cuts.

Portfolio returns were supported by Schrodgers, which benefitted from its commodity-related equity positions, such as Gold mining companies and energy companies. A regional preference for Emerging Markets also provided a tailwind to returns. TrinityBridge also provided strong returns over the month, with stock selection and a large allocation to Gold supporting performance.

No manager allocation changes were made this month, as we believe current positioning remains optimal. Key changes from managers include Growth-Aligned adding to equities in the UK, Europe and Emerging Markets and Allianz increasing exposure to UK government bonds at the expense of US bonds. UBS also reduced US Treasuries.

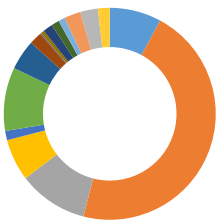
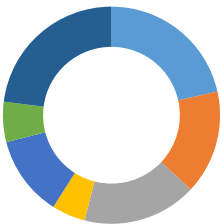

As a result, some of our fund OCFs (Ongoing Charges Figure) have significantly decreased, reflecting only the costs that directly affect the fund's assets.

What are the fees associated with investing in this Portfolio?

The OCF of this Portfolio is currently 0.73%. This means that if you invest £1000 in the Portfolio, you can expect to pay £7.29 in fees over the course of a year. The fees you pay are pro-rata. If you hold the Portfolio for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk Type	Description
