Fund objective

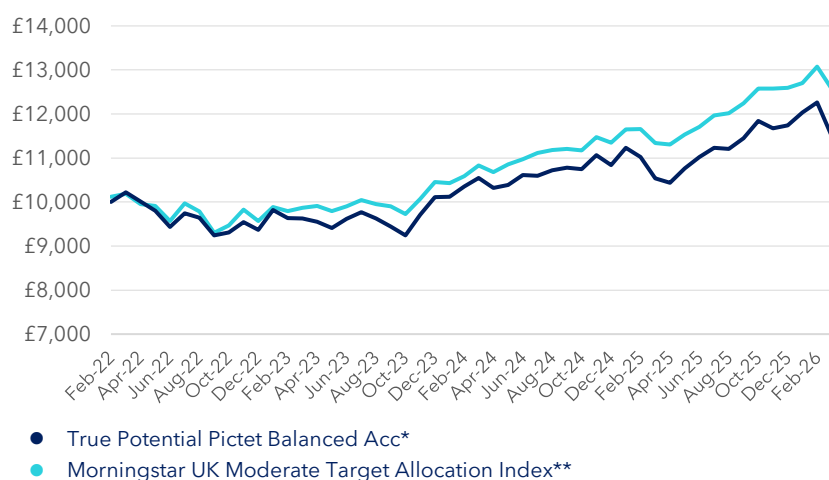
The Fund seeks to deliver growth over a rolling 3 year period net of fees.

March Update

Global equities fell sharply in March as war in the Middle East sparked a sell-off across all risk assets. Emerging Market (EM) equities markedly underperformed their developed market counterparts. In developed markets, Japanese shares proved a laggard, while US equities fared better yet also notably declined. In fixed income, UK Gilts underperformed, with longer-dated bonds particularly weak amid higher yields. Elsewhere, oil rallied while gold tumbled amid a stronger US dollar.

The True Potential Pictet Balanced Fund returned -6.35% (net of fees). The allocations to global thematic equity funds produced negative returns, with the robotics theme proving the laggard over the month. Meanwhile, the sustainable equities, clean energy and AI-driven themes fared slightly better yet lagged the broader market. Elsewhere, the Fund's exposure to global miners via the Van Eck S&P Global Mining ETF notably detracted. The position in Japanese equities also weighed on performance. More positively, the Fund's exposure to the S&P Energy Future delivered the best gains overall as oil prices rallied. In fixed income, the Fund's exposure to high-yield convertible bonds via the SPDR FTSE Global Convertible Bond ETF detracted. Elsewhere, the Fund's allocation to EM local-currency debt via the Pictet Emerging Local Currency Debt Fund also hurt performance. In alternatives, the allocation to commodities via the UBS Commodities ETF delivered solid gains. Elsewhere, the Fund hedging its US dollar exposure back to sterling detracted.

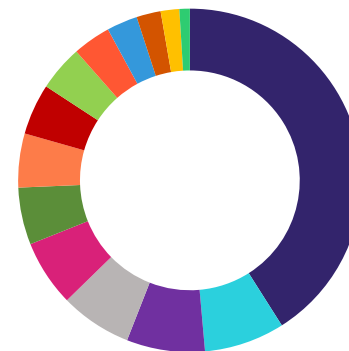
What are the fees associated with investing in this fund?

The OCF of this fund is currently 0.74%. This means that if you invest £1000 in the fund, you can expect to pay £7.40 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
