

# True Potential UBS Cautious

## Fund objective

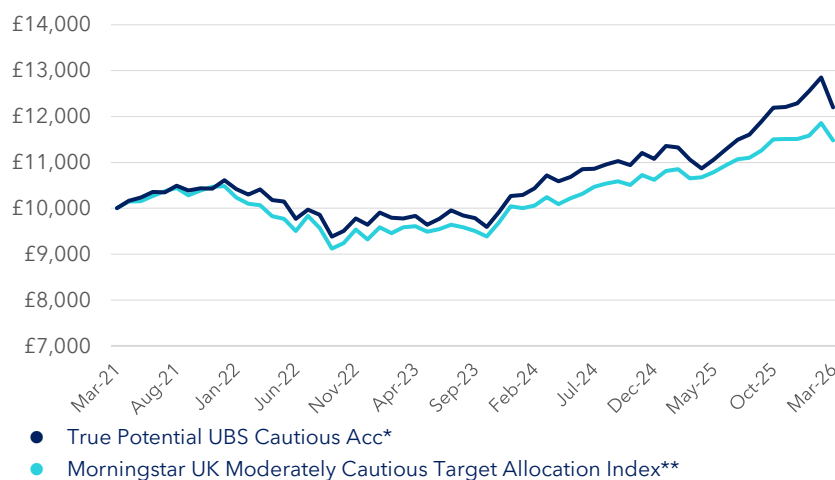
The Fund aims to achieve growth over the long term (5 years or longer) through active management of a diversified investment portfolio whilst seeking to control the overall level of portfolio risk.

## March Update

Global equities fell sharply in March as war in the Middle East sparked a sell-off across all risk assets. Emerging Market (EM) equities markedly underperformed their developed market counterparts. In developed markets, Japanese shares proved a laggard, while US equities fared better yet also notably declined. In fixed income, UK Gilts underperformed, with longer-dated bonds particularly weak amid higher yields. Elsewhere, oil rallied while gold tumbled amid a stronger US dollar.

The True Potential UBS Cautious Fund returned -5.07% (net of fees), with a large exposure to equities, particularly EM and Japanese shares, proving a hindrance as riskier assets significantly underperformed over the month. The Fund's exposure to European banks and Chinese technology stocks also weighed on returns. All of the allocations to index funds that track global equity factors produced losses, with the 'quality' and 'momentum' factors faring the worst. Conversely, the 'defensive', 'value' and 'minimum volatility' factors proved more resilient. In fixed income, UK Gilts underperformed US Treasuries, while EM debt and investment-grade corporate credit also hurt returns. Meanwhile, the allocation to US high-yield bonds and the UBS China Fixed Income Fund fared better but still delivered slight negative returns. The alternatives segment produced mixed results, with the allocation to the UBS Global Equity Long Short Fund delivering solid gains. Elsewhere, exposure to gold proved a notable detractor.

## What are the fees associated with investing in this fund?

The OCF of this fund is currently 0.63%. This means that if you invest £1000 in the fund, you can expect to pay £6.30 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
