Portfolio Objective

The objective of the True Potential Balanced + Portfolio is to provide investors with a way to achieve their investment goals. The Portfolio offers exposure to a select group of investment partners and a range of risk profiles (Defensive to Aggressive), whilst remaining within the Balanced risk profile. We review the Portfolio monthly and, if necessary, rebalance to the allocation of styles that we believe offers the best opportunity for growth within the Balanced risk profile. The Portfolio aims to produce a higher risk-adjusted outcome at a lower average cost, compared to an equally-weighted model of Balanced funds.

Investment Commentary

The True Potential Balanced + Portfolio returned -1.01% in July 2026.

During the month, UK equities performed strongly, helped by Energy and Financials. Europe also held up well due to resilient company earnings. This was offset by weaker performance in the US and Emerging Markets, including Korea, as investors questioned whether AI-related earnings growth could continue.

Government bond yields rose in the US and UK as higher oil prices added to inflation concerns. Credit markets weakened, although High Yield bonds performed better than Investment Grade bonds. Sterling strengthened against the Dollar and Euro.

True Potential Schrodgers Cautious was a positive contributor, benefiting from overseas equities, particularly Japan, and diversifying alternatives. TrinityBridge Growth lagged due to the higher allocation to US equities and sovereign bonds.

During the month, exposure to TrinityBridge Growth was reduced and Allianz Growth was increased. This kept the overall asset allocation broadly unchanged while improving resilience to inflation risks.

Managers continued to reduce Emerging Markets exposure and add to Japan. Schrodgers lowered technology exposure within Emerging Markets, while Allianz and SEI also reduced Emerging Markets. Growth-Aligned appointed M&G as a new UK equity manager.

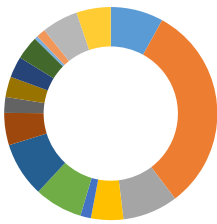
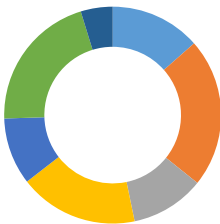

As a result, some of our fund OCFs (Ongoing Charges Figure) have significantly decreased, reflecting only the costs that directly affect the fund's assets.

What are the fees associated with investing in this Portfolio?

The OCF of this Portfolio is currently 0.78%. This means that if you invest £1000 in the Portfolio, you can expect to pay £7.80 in fees over the course of a year. The fees you pay are pro-rata. If you hold the Portfolio for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk Type	Description
