

True Potential Defensive Portfolio

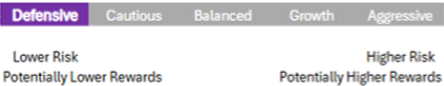

Portfolio Objective

The objective of the True Potential Defensive Portfolio is to provide investors with a way to achieve their investment goals. The Portfolio offers full exposure to different manager styles within the Defensive risk profile. We review the Portfolio monthly and, if necessary, rebalance to the allocation of styles that we believe offers the best opportunity for growth within the Defensive risk profile. The Portfolio aims to produce a higher risk-adjusted outcome at a lower average cost, compared to an equally-weighted model of Defensive funds.

Risk and Reward Profile



The Defensive Investor may be very sensitive to short-term losses. A Defensive Investor's potential aversion to short-term losses could compel them to sell their investment and hold a zero risk investment instead if losses occur. Defensive Investors would possibly accept lower long-term return in exchange for smaller and less frequent changes in portfolio value. Analysing the risk-return choices available, a Defensive Investor is usually willing to accept a lower return in order to assure the safety of his or her investment.

Investment Commentary

The True Potential Defensive Portfolio returned -0.51% in July 2026.

During the month, UK equities performed strongly, helped by Energy and Financials. Europe also held up well due to resilient company earnings. This was offset by weaker performance in the US and Emerging Markets, including Korea, as investors questioned whether AI-related earnings growth could continue.

Government bond yields rose in the US and UK as higher oil prices added to inflation concerns. Credit markets weakened, although High Yield bonds performed better than Investment Grade bonds. Sterling strengthened against the Dollar and Euro.

True Potential SEI Defensive was the strongest contributor, helped by lower-risk equity styles and bonds that were less sensitive to interest rate changes. Pictet Defensive was the weakest contributor, mainly due to technology-focused themes being hurt by weaker sentiment and higher bond yields.

No changes were made to fund allocations in July, with the team comfortable with the current level of risk, manager and asset allocation.

At fund level, SEI reduced Emerging Markets exposure after strong recent performance. Growth-Aligned added Japanese equities and appointed M&G as a new UK equity manager.

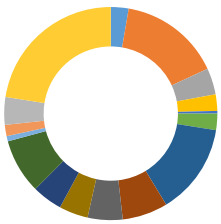
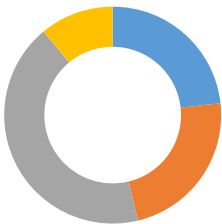

As a result, some of our fund OCFs (Ongoing Charges Figure) have significantly decreased, reflecting only the costs that directly affect the fund's assets.

What are the fees associated with investing in this Portfolio?

The OCF of this Portfolio is currently 0.67%. This means that if you invest £1000 in the Portfolio, you can expect to pay £6.70 in fees over the course of a year. The fees you pay are pro-rata. If you hold the Portfolio for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk Type	Description
